What is this product?

Type: UCITS

Term: There is no fixed term for this Sub-Fund.

Objectives: The Sub-Fund's investment objective is to achieve long-term capital appreciation and a dividend on each Dividend Payment Date up to the Target Date. Following the Subscription Period (during which the Sub-Fund will gain exposure either directly or indirectly via units of Underlying Funds to short, medium and/or long term instruments, such as certificates of deposit, commercial paper, banker's acceptances and fixed and/or floating rate transferable debt securities i.e. the "Initial Strategies"), the Sub-Fund seeks to achieve its objective by rotating out of the Initial Strategies into the Longer Term Strategies. The Sub-Fund's asset allocation to the Initial Strategies will reduce by 5% on a quarterly basis up to the Target Date. Each reduction will be followed by a corresponding investment by the Sub-Fund in the Longer Term Strategies (the "Averaging Out"). The Manager can alter the percentage disclosed above by accelerating or decelerating the reduction to the Initial Strategies according to their view of market conditions and to mitigate the risk of short-term price fluctuations in the market on or around each quarter period end. The Manager's view on market conditions will be informed by a proprietary quantitative model designed by the Manager and/or by qualitative considerations that include macroeconomic conditions, valuations and risk sentiment. Exposure to the Longer Term Strategies may be achieved by purchasing Underlying Funds with exposure to: i) equities issued by companies incorporated anywhere in the world; ii) government or corporate debt securities of Investment Grade and/or non-Investment Grade with a fixed or floating rate; iii) absolute return/alternative investment strategies, including Underlying Funds with indirect exposure to commodities; and iv) money market instruments, such as certificates of deposit, commercial paper, treasury bills, and banker's acceptances. Investments in Underlying Funds will be selected based on a number of factors, including investment policy and objectives, investment strategy and process, performance track record, team structure and risk management. The Manager uses in-house qualitative and quantitative techniques to evaluate, select and perform on-going monitoring of Underlying Funds and their investment managers. The Sub-Fund may use derivatives to reduce various risks, for hedging and investment purposes. The recommended holding period has been selected as the link between the risk and the potential returns of the Sub-Fund and can be fully appreciated only over the recommended holding period. Benchmark Information: The Sub-Fund is not managed in reference to any benchmark. The portfolio composition is determined based on active investment decisions and hence the Sub-Fund is actively managed. This PRIIPs KID should be read in conjunction with the ICAV Prospectus and the Sub-Fund Supplement. There can be no guarantee that the investment objective will actually be attained, and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product nor a capital protected product. Investors can redeem their Shares on the relevant Dealing Day as set out in the Prospectus. Investors can ask for full or partial redemption of the Shares held.

What are the risks and what could I get in return?

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Sub-Fund is not able to pay you.
- We have classified this product as 3 out of 7, which is a medium-low risk class.
- This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the Sub-Fund to pay you.

- This product does not include any protection from future market performance so you could lose some or all of your investment.
- If the ICAV is not able to pay you what is owed, you could lose your entire investment.

What happens if Fineco Asset Management DAC is unable to pay out?

If the Manager were to become insolvent, the assets of the Sub-Fund should not be affected because they are held by the Depositary, which is legally required to keep the assets separate from its own assets and those of the Manager. However, if the Depositary were to become insolvent, there may be a financial loss for the Sub-Fund, but this should be minimized because the assets are held separate to the Depositary's own assets. If the Sub-Fund is closed or dissolved, the assets will be sold and the investors will receive a share of the proceeds, which may be more or less than their initial investment.
