## What is this product?

**Type:** UCITS

**Term:** There is no fixed term for this Sub-Fund.

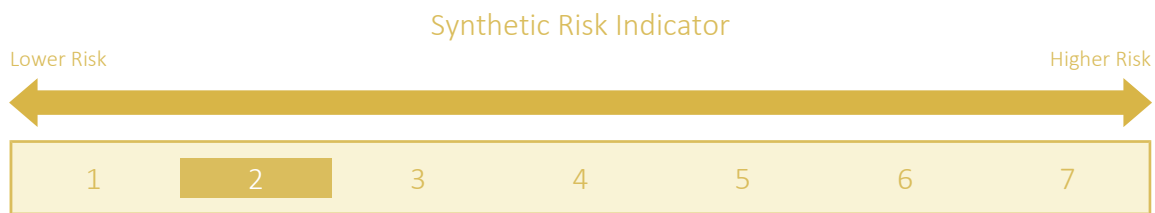
**Objectives:** Term: Notwithstanding that a Maturity Date of 23 August 2027 applies to the Sub-Fund, there is no fixed term for this Sub-Fund.

Objectives: The investment objective of the Sub-Fund is to (i) achieve capital growth and (ii) seek to protect the Fund's Net Asset Value per Share at 100% of the Initial Offer Price, during the life of the Fund up to the Maturity Date. In order to achieve its Investment Objective the Sub-Fund will invest in Equity Instruments of issuers listed or traded on developed market stock exchanges or companies considered by the Manager to be developed market companies and/or Debt Instruments including government and/or corporate bonds with a preference for Investment Grade government bonds and/or Debt Instruments issued by developed market governments and/or companies (the "Funding Investments"). The Sub-Fund will then use the return it receives from the exposure to the Funding Investments described above (plus any cash the Fund may hold that was not used to purchase the Funding Investments) to enter into a swap which involves an OTC counterparty paying the Fund a return linked to a standard market interest rate. At the time of purchase of the Debt Instruments, the Sub-Fund may only purchase, in aggregate, up to 20% of its Net Asset Value in either non-Investment Grade and/or subordinated debt. During the Subscription Period, approaching the Maturity Date and after the Maturity Date, the Sub-Fund may invest principally in Debt Instruments and/or Money Market/Short Term Instruments. The Sub-Fund may enter into a series of Financial Derivative Instruments ("FDI") which may include total return swaps, credit default swaps, options, via which FDIs the Sub-Fund may take exposure to other indices as well. The Sub-Fund may engage in securities lending for efficient portfolio management purposes and may use additional FDI to those listed above for investment purposes, hedging and risk reduction. The Sub-Fund is not managed in reference to a benchmark. Portfolio composition is determined based on active investment decisions and hence the Sub-Fund is actively managed. The recommended holding period has been selected as the link between the risk and the potential returns of the Sub-Fund and can be fully appreciated only over the recommended holding period. Please refer to the Supplement for the other types of FDIs that can be used by the Sub-Fund. This PRIIPs KID should be read in conjunction with the ICAV Prospectus and the Sub-Fund Supplement. There can be no guarantee that the investment objective will actually be attained and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product. Investors can redeem their Shares on the relevant Dealing Day as set out in the Prospectus. Investors can ask for full or partial redemption of the Shares held.

## What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years.

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Sub-Fund is not able to pay you.
- We have classified this product as 2 out of 7, which is a low risk class.
- This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the Sub-Fund to pay you.
- This product does not include any protection from future market performance so you could lose some or all of your investment.
- If the ICAV is not able to pay you what is owed, you could lose your entire investment.

## Performance Scenarios

## What happens if Fineco Asset Management DAC is unable to pay out?

If the Manager were to become insolvent, the assets of the Sub-Fund should not be affected because they are held by the Depositary, which is legally required to keep the assets separate from its own assets and those of the Manager. However, if the Depositary were to become insolvent, there may be a financial loss for the Sub-Fund, but this should be minimized because the assets are held separate to the Depositary's own assets. If the Sub-Fund is closed or dissolved, the assets will be sold and the investors will receive a share of the proceeds, which may be more or less than their initial investment. The ICAV is not a guaranteed UCITS and as a result there is no guarantee scheme in place which provides a guaranteed rate of return. The Sub-Fund does not provide compensation or operate a guarantee against any loss in the value of an investment, the funds or any income generated.

## What are the costs?

### Costs over Time

The recommended holding period of the Sub-Fund is expected to be 3 years. The recommended holding period of 3 years is based on the liquidity profile of the Sub-Fund as well as the risk profile of the underlying assets. Investors can redeem their units on the relevant Dealing Day as set out in the prospectus by placing an order with the Distributor. No fees or penalties are applied by the Manager.
