#### What is this product?

Type: UCITS

Term: There is no fixed term for this Sub-Fund.

Objectives: The investment objective of the Sub-Fund is to provide long-term income and capital growth. The Sub-Fund invests primarily in bonds rated as investment grade by one or more of the main credit rating agencies, which are denominated in Euro and may be issued by governments, government agencies or companies. The Manager selects investments and creates the portfolio by performing both top-down and bottom-up investment analysis. The bottom-up analysis focuses on transparency and corporate governance criteria and an assessment of legal, reputational and environmental risks as well as an analysis of asset valuations. The top-down analysis focuses on the Manager's expectations regarding macroeconomic conditions such as growth, inflation and trends in corporate credit quality. The Sub-Fund may also invest in non-Euro denominated bonds, contingent convertible bonds (i.e. bonds that may at some point convert to equities), and bonds that are rated below investment grade by one or more of the main ratings agencies. The Sub-Fund may use derivatives for investment purposes, to reduce various risks or for efficient portfolio management. point ii below). The recommended holding period has been selected as the link between the risk and the potential returns of the Sub-Fund and can be fully appreciated only over the recommended holding period. Benchmark Information: The Sub-Fund is actively managed. The Manager, considering the degree of representativeness of the underlying markets and their liquidity, strategically selects a benchmark (the "Benchmark") appropriate to the Sub-Fund's investment policies, which is used as performance comparison. The selected Benchmark is Benchmark: Markit iBoxx EUR Corporates Index. The Sub-Fund does not aim to track or replicate the performance of the Benchmark and therefore investors should be aware that the Sub-Fund may underperform the Benchmark. There can be no guarantee that the investment objective will actually be attained and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product. Investors can redeem their shares on the relevant Dealing Day as set out in the prospectus. Investors can ask for full or partial redemption of the shares held. SFDR Classification: The Sub-Fund is classified as an Art. 8 financial product under SFDR. # What happens if Fineco Asset Management DAC is unable to pay out?

If the Manager were to become insolvent, the assets of the Sub-Fund should not be affected because they are held by the Depositary, which is legally required to keep the assets separate from its own assets and those of the Manager. However, if the Depositary were to become insolvent, there may be a financial loss for the Sub-Fund, but this should be minimized because the assets are held separate to the Depositary's own assets. If the Sub-Fund is closed or dissolved, the assets will be sold and the investors will receive a share of the proceeds, which may be more or less than their initial investment. The ICAV is not a guaranteed UCITS and as a result there is no guarantee scheme in place which provides a guaranteed rate of return. # How long should I hold it and can I take money out early?

## Recommended holding period: 4 years

The recommended holding period of the Sub-Fund is expected to be 4 years. The recommended holding period of 4 years is based on the liquidity profile of the Sub-Fund as well as the risk profile of the underlying assets. In order to sell shares, investors must do so with the assistance of an intermediary (e.g. a stockbroker) and may incur fees for doing so. In addition, investors may receive less than the current Net Asset Value when selling shares. Typically, only authorised participants can purchase shares directly from or sell shares directly back to the Sub-Fund. Shareholders should consult the section of the prospectus entitled "Dealing in shares in the Secondary Market" for details on the limited circumstances where shares purchased on the secondary market may be sold directly back to the Sub-Fund. No fees or penalties are applied by the Manager.
