## What is this product?

**Type:** UCITS

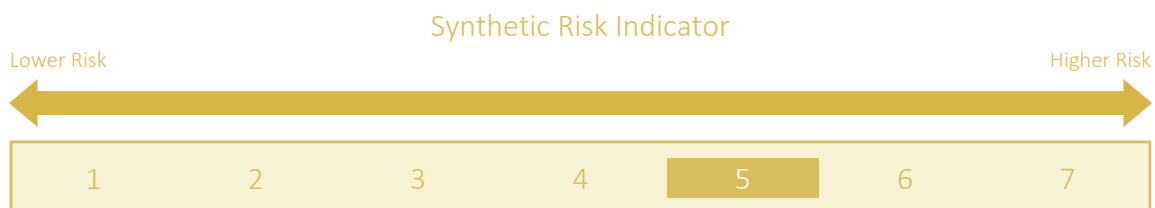
**Term:** There is no fixed term for this Sub-Fund.

**Objectives:** The investment objective of the Sub-Fund is capital appreciation over the medium to long term through investment in a diversified portfolio of European equity securities. The Sub-Fund will invest predominantly in equity securities issued by companies with their principal offices in, or are headquartered in, Europe. The Investment Manager will apply a value investment approach and will seek to acquire equities at prices that are below their intrinsic value. Stock selection will be based on fundamental analysis and bottom-up evaluation of companies that will focus on valuation levels, earnings performance and appraisal of an issuer's management and industry sector. When the Investment Manager considers it is appropriate, the Sub-Fund may invest in aggregate up to 25% of its net assets in collective investment schemes, exchange traded sub-funds ("ETFs") and ancillary liquid assets such as money market instruments. The Sub-Fund may use derivatives to reduce various risks or for efficient portfolio management. The recommended holding period has been selected as the link between the risk and the potential returns of the Sub-Fund and can be fully appreciated only over the recommended holding period. **Benchmark Information:** The Sub-Fund is actively managed. The Investment Manager, considering the degree of representativeness of the underlying markets and their liquidity, strategically selects a benchmark (the "Benchmark") appropriate to the Sub-Fund's investment policies, which is used as i) performance comparison and ii) basis for the value-at risk ("VaR") calculations. The selected Benchmark is MSCI Europe Value Index. The Sub-Fund does not aim to track or replicate the performance of the Benchmark and therefore investors should be aware that the Sub-Fund may underperform the Benchmark. There can be no guarantee that the investment objective will actually be attained, and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product. Investors can redeem their shares on the relevant Dealing Day as set out in the prospectus. Investors can ask for full or partial redemption of the shares held. **SFDR Classification:** The Sub-Fund is classified as an Art. 8 financial product under SFDR. This means that, by pursuing its objective, this Sub-Fund promotes, among other characteristics, environmental and/or social characteristics, including the investment in companies that follow good governance practices ("ESG"). ## What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years.

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Sub-Fund is not able to pay you.
- We have classified this product as 5 out of 7, which is a medium-high risk class.
- This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact the capacity of the Sub-Fund to pay you.
- This product does not include any protection from future market performance so you could lose some or all of your investment.
- If the ICAV is not able to pay you what is owed, you could lose your entire investment.

## Performance Scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product / a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

## What happens if Fineco Asset Management DAC is unable to pay out?

If the Manager were to become insolvent, the assets of the Sub-Fund should not be affected because they are held by the Depositary, which is legally required to keep the assets separate from its own assets and those of the Manager. However, if the Depositary were to become insolvent, there may be a financial loss for the Sub-Fund, but this should be minimized because the assets are held separate to the Depositary's own assets. If the Sub-Fund is closed or dissolved, the assets will be sold and the investors will receive a share of the proceeds, which may be more or less than their initial investment. The ICAV is not a guaranteed UCITS and as a result there is no guarantee scheme in place which provides a guaranteed rate of return. The Sub-Fund does not provide compensation or operate a guarantee against any loss in the value of an investment, the funds or any income generated.

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. Recommended holding period: 5 years

The recommended holding period of the Sub-Fund is expected to be 5 years. The recommended holding period of 5 years is based on the liquidity profile of the Sub-Fund as well as the risk profile of the underlying assets. Investors can redeem their units on the relevant Dealing Day as set out in the prospectus by placing an order with the Distributor. No fees or penalties are applied by the Manager.
