## What is this product?

**Type:** UCITS

**Term:** There is no fixed term for this Sub-Fund.

**Objectives:** The investment objective of the Sub-Fund is to achieve income and capital growth. The Sub-Fund invests predominantly in fixed rate investment grade bonds denominated in Euro with less than five years to maturity. The Investment Manager will select the bonds to be acquired by focusing on fundamental research and bottom-up security selection analysis. The Investment Manager's sovereign and corporate analysts provide a fundamental assessment of a country or company's financial health, with focus on credit assessments to appraise the probability of default and estimate losses. Following such credit assessment, the Investment Manager appraises investments in reference to other investment opportunities by focusing on relative price, liquidity and risk premium with the purpose of determining which investments to acquire on behalf of the Sub-Fund. The Sub-Fund may invest materially in non-Euro denominated debt securities which may or not be hedged back to Euro. The Sub-Fund may also invest in collateralized debt obligations (CDOs) or collateralized loan obligations (CLOs). The Sub-Fund may use derivatives for investment purposes, to reduce various risks or for efficient portfolio management. The recommended holding period has been selected as the link between the risk and the potential returns of the Sub-Fund and can be fully appreciated only over the recommended holding period. The Sub-Fund is actively managed. The Manager has selected the ICE BofA 1-3 Year Euro Broad Market Index for performance comparison purposes only. The Manager does not intend to replicate the composition of such index and may at all times exercise total freedom by investing in securities which are not included in the referenced index, or which are present in different proportions. There can be no guarantee that the investment objective will actually be attained and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product. Investors can redeem their shares on the relevant Dealing Day as set out in the prospectus. Investors can ask for full or partial redemption of the shares held. **SFDR Classification:** The Sub-Fund is classified as an Art. 8 financial product under SFDR. This means that, by pursuing its objective, this Sub-Fund promotes, among other characteristics, environmental and/or social characteristics, including the investment in companies that follow good governance practices ("ESG"). ## What are the risks and what could I get in return?



- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Sub-Fund is not able to pay you.
- We have classified this product as 2 out of 7, which is a low risk class.
- This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the Sub-Fund to pay you.

## What happens if Fineco Asset Management DAC is unable to pay out?

If the Manager were to become insolvent, the assets of the Sub-Fund should not be affected because they are held by the Depositary, which is legally required to keep the assets separate from its own assets and those of the Manager. However, if the Depositary were to become insolvent, there may be a financial loss for the Sub-Fund, but this should be minimized because the assets are held separate to the Depositary's own assets. If the Sub-Fund is closed or dissolved, the assets will be sold and the investors will receive a share of the proceeds, which may be more or less than their initial investment. ### Costs over Time

Investors can redeem their units on the relevant Dealing Day as set out in the prospectus by placing an order with the Distributor. No fees or penalties are applied by the Manager.
