### Objectives and Investment Policy

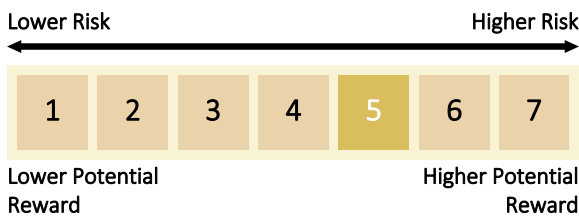
The investment objective of the Sub-Fund is to achieve income and long-term capital growth principally through investment in income producing equities globally. The Investment Manager targets investments which it believes offer attractive dividend yields in addition to price appreciation applying fundamental analysis to seek companies whose intrinsic value is greater than the current price of their securities. This approach includes fundamental analysis of a company's financial statements, profitability, management structure, operations, business strategy, product development, and its position within its industry, among other things. The Investment Manager evaluates investment opportunities on a company-by-company basis. The Investment Manager looks primarily for companies using a "bottom up" strategy, that is, by analyzing individual stocks before considering the impact of general or industry economic trends. The Sub-Fund invests across global geographies and in equities of issuers in any market sector. The Sub-Fund may also hold money market instruments such as treasury bills. The Sub-Fund may use derivatives for investment purposes, to reduce various risks or for efficient portfolio management. The Fund is actively Managed. The Fund does not aim to track the performance of a benchmark. Portfolio composition is determined based on active and discretionary investment decisions and choices. There can be no guarantee that the investment objective will actually be attained and investors are explicitly warned that this Sub-Fund is not a capital guaranteed product. Investors can redeem their Shares on any business day in Luxembourg. Investors can ask for full or partial redemption of the Shares held. **SFDR Classification:** The Sub-Fund is classified as an Art. 8 financial product under SFDR. This means that, by pursuing its objective, this Sub-Fund promotes, among other characteristics, environmental and/or social characteristics, including the investment in companies that follow good governance practices ("ESG"). #### Additional key risks

#### What does this risk indicator mean?

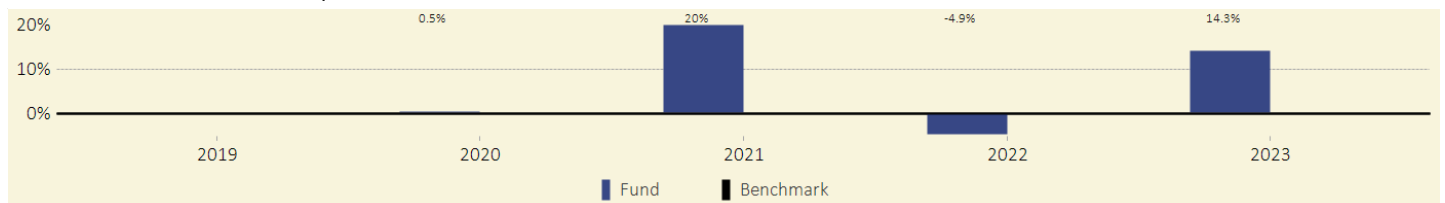
